Since 1897, philanthropy has played a vital role in our healing ministry and mission. As I walk through the halls of our hospitals, I am incredibly proud of our philanthropic partners whose gifts have helped create healing environments and award winning programs and services. At every turn, there is evidence of their impact...the Karl J. Krapek, Sr. Comprehensive Women's Health Center; the John, Carmela and Theresa Trani Oncology Pavilion; the Art and Mariko Byrne Surgery Pavilion; the Joyce D. and Andrew J. Mandell Center for Comprehensive Multiple Sclerosis and Neuroscience Research; the Lea Economos Hematology Center for Clinical Research; Hoffman Heart and Vascular Institute; Hoffman Breast Health Center; and the John T. O'Connell Tower, to name a few. In addition, gifts from our the Auxiliary of Saint Francis, Woodland Anesthesiology Associates, Ranjana and Surendra Chawla, M.D., Radiology Associates of Hartford, Saint Francis Hospital School of Nursing Alumni, United Technologies, Travelers, and Stanley Black & Decker can be felt throughout our hospitals.

This year we are blessed to add another patient-centered service area to our hospital. The extraordinary gift of \$1.5M by Barbara Vicevich will provide the funds to create the Vicevich Multi-Specialty Pavilion and Lupus Center which will open in the spring of 2019. This state-of-the-art medical "neighborhood" will provide one-stop comprehensive clinical care for patients with lupus and complex rheumatologic disease. Barbara's gift is in memory of her beloved mother Margery and in honor of her brother Jim along with his primary care physician, Michael Grey, M.D., Chairman, Department of Medicine.

We also received a second grant from the W.K. Kellogg Foundation in the amount of \$2.1M to continue and expand the "Breastfeeding: Heritage and Pride" Program (BHP) in partnership with the Hispanic Health Council in collaboration with Walter Trymbulak, M.D., Ph.D., Vice Chairman, Saint Francis' Women and Infants Service Line. These funds will be used to create a path for the replication of BHP at 40 other Trinity Health hospitals.

In February, we received a bequest of \$5M from an anonymous donor which will benefit oncology research and our Hope & Healing Campaign. This gift, as well as numerous others, helped the Foundation celebrate its most successful year in history, raising more than \$16M in gifts and pledges.

Our signature events, MIRACLES, Swing and the JMH golf tournament exceeded all expectations generating more than \$1.5M in revenue. Proceeds from our events support patient-related programs, services, and equipment needs. Our sponsors and participants play a very important role in the success of these events and we are very honored by their continued support.

All of these wonderful gifts remind me of the story of Mother Valencia who arrived in 1897 as the hospital's first administrator with less than \$10 in her pocket. She invested every cent to heal and care for the poor. We truly believe that she set the standard for patient-centered care and the vital importance of philanthropy.

On behalf of presidents John F. Rodis, M.D., M.B.A., Robert J. Krug, M.D. and Stuart E. Rosenberg, M.B.A., we hope you know how deeply grateful we are for every precious gift that is donated to our hospitals. Each donation, large or small, has a transformational effect on our patients, and their families. # Andrew J. and Joyce D. Mandell Family Foundation

**FAMILY FOUNDATION** – Family Foundations work together to have a meaningful and measurable impact on social problems. They also have a unique purpose...to serve as a unified vehicle for multiple generations.

The Mandell family began their family foundation in 1984 after purchasing a raffle ticket from a local charity and ultimately winning a brand new Cadillac. Electing a cash prize of \$12,500, they formed the *Andrew J. and Joyce D. Mandell Family Foundation*. “Opportunities come along all the time. It’s what you do with them that counts,” contends Andy. They immediately named their three children — Bruce, Mark, and Meryl — who were in their teens and pre-teens at the time, as the directors of the Foundation. “We wanted to share with our children the wonderful culture of community involvement that has so enriched our lives. Putting our children in decision-making roles for the family foundation seemed like a good way to foster this legacy,” explains Joyce.

**IMPACT** Our Philanthropic partnership with the Mandell Family Foundation has left an indelible mark on the lives of our patients and their families. In 2008, the Mandells established the Joyce D. and Andrew J. Mandell Center for Comprehensive Multiple Sclerosis Care and Neuroscience Research and after 10 years of service, they recorded their three thousandth patient. The Mandell MS Center at Mount Sinai is a nationally recognized leader in the care and research of multiple sclerosis. The comprehensive care includes a team of specialists, a broad range of therapeutic programs, a dedicated infusion therapy suite and groundbreaking research projects and clinical trials. In 2018, they expanded their programs and comprehensive services to Saint Mary’s Hospital in Waterbury. The Mandell’s most recent seven-figure gift will establish an oncology rehabilitation program and healing garden at the Smilow Cancer Hospital at Saint Francis when the current center is expanded.

United Technologies strives to improve people's quality of life everywhere they do business. By investing in their communities, they are improving the health care of their colleagues and their neighbors. They have been a partner of Saint Francis and the Smilow Cancer Hospital at Saint Francis for decades, including assisting in the building of the current Cancer Center and the purchase and maintenance of our CyberKnife technology. Another component will be a comprehensive oncology rehabilitation center. This state-of-the-art facility will provide our cancer patients with services and therapies that will restore their strength and endurance while reducing their stress, pain, anxiety and depression. Groundbreaking on the addition is expected to take place in late 2019.

## Patricia Browning Stone Sensory Playground

### ANONYMOUSLY GIVING THE GIFT OF JOY... TIMES TWO

In 2017, the Foundation was approached by a generous donor whose goal was to make a difference in the lives of the children in the behavioral health program at Mount Sinai. Collaborating with the behavioral health team, months were spent painstakingly choosing just the right equipment to construct the Patricia Browning Stone Sensory Playground. Months later, the Foundation received notification that a second gift would be forthcoming from another donor to maintain the playground for years to come. Both gifts were anonymous and will have a profound impact on the children that are in the ABC/CAPS units on the Mount Sinai campus. The playground opened in the spring and is used daily, much to the delight of our patients and their caregivers.

**IMPACT** The inpatient services for children and adolescents include dedicated units for children, the Acute Behavioral Child Unit for youngsters ages 5 to 12; and adolescents, the Child Adolescent Psychiatric Services for teens ages 13 to 18. The treatment approach is grounded in affirmation and the restoration of self-worth for children who have experienced disruption of early attachment. Within a creative and healing environment, our staff provides specialized care for each child, guiding them on their path toward healthy coping, problem-solving and successful relationships with their world.

## McPhee Family

**GRATEFUL FAMILY** – Grateful patients and their families have a profound impact on our ability to serve our community. Their philanthropic investments allow us to create healing environments, purchase state-of-the-art equipment, attract world-class physicians, expand research through clinical trials and help our most vulnerable patients. One such family that believes in improving the health and well-being of our community are the McPhees.

Barbara and Michael McPhee donated \$45,000 to support our Advanced Care Planning (ACP) program. **IMPACT** Establishing this program will ensure that medical providers, patients and their family members have a clear set of guidelines to follow if/when a patient is no longer able to communicate their wishes toward the end of their life. The first phase of the program will include communication skills training for physicians and medical staff and installation of an electronic documentation data system to measure the quality of care for seriously ill patients.

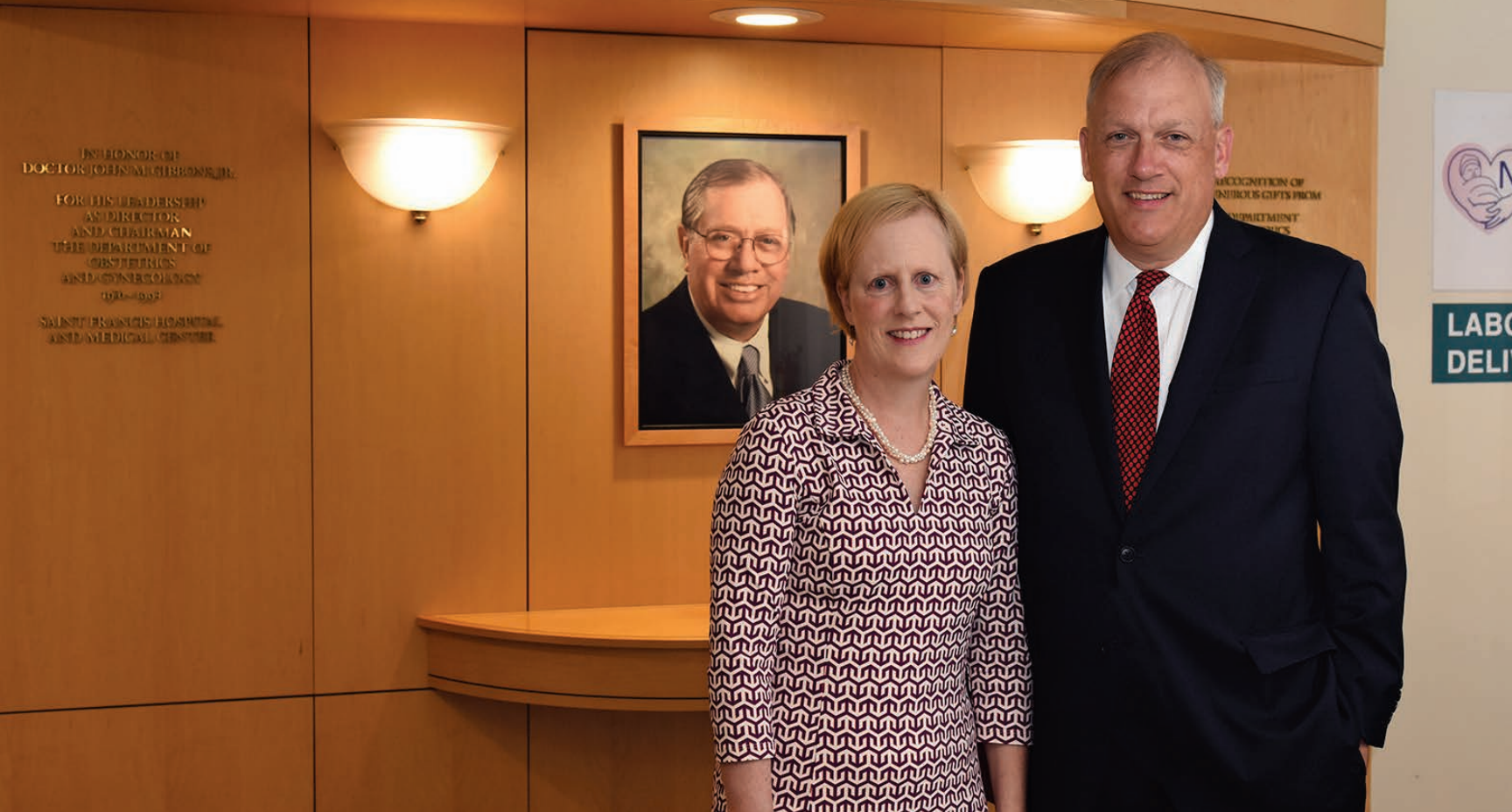

## Myles & Tracy Gibbons

### STOCK GIFT

For several years, Myles and Tracy Gibbons have chosen to donate appreciated stock to Saint Francis. This option offers tax savings while avoiding capital gains tax on the value of the donation. It also allows for the full, total value of the shares to be credited to the hospital. The process is very easy. Once an appreciated stock or mutual fund is identified to be used as a donation, Saint Francis provides the wire instructions directly to the donor's broker, who can then process the transaction. In the end, the Gibbons family can make a larger donation than if they sold the stock themselves, paid the capital gains tax, and donated the net proceeds.

**IMPACT** Over the years, Myles and Tracy have requested their stock gifts be unrestricted which means they can be used to support the area of greatest need. It gives the hospital leadership appropriate discretion to support the mission of enhancing patient care, strengthen the organization, and improving the health of our community. Most recently, the Gibbons opted to direct their contribution to *The John M. Gibbons Pavilion for Women* — a unique opportunity to continue Dr. Gibbons' legacy.



## The Richard P. Garmany Fund

**DONOR-ADVISED FUND** – Creating a donor-advised fund provides an opportunity for a donor to play an active role in determining which charities and programs their fund will support.

A grant of \$32,000 was awarded by the Hartford Foundation for Public Giving through the Richard P. Garmany Fund, a donor-advised fund. This type of fund is created when a donor contributes cash or assets to a public charity, which in turn creates a separate account for the donor. The donor or fund designee then recommends disbursements from the fund to their favorite public charities.

**IMPACT** This is the second grant awarded by the Garmany Fund to support the Music Therapy program run by the Integrative Medicine Department at Saint Francis. With this grant, services will be offered to all patients including cancer, palliative care, behavioral health, as well as, our tiniest patients in the NICU, which overall represents 3,200 patients a year.

## Robert & Carole Goldberg

**IRA ROLLOVER** – At age 70½, individuals who own an Individual Retirement Account (“IRA”) are required to begin withdrawals known as required minimum distributions (“RMD”). A provision within the Pension Protection Act of 2006 allowed individuals, who owned an IRA and were 70½, the ability to transfer up to \$100,000 every year from their IRA directly to a qualifying nonprofit without tax penalties.

Since 2015, Robert (Bob) and Carole Goldberg have used their IRA to make their annual charitable contributions. They wanted to maximize the tax benefits of their charitable gifts while supporting an area of care that was important to them. Saint Francis is grateful to their more than \$100,000 in support of cardiology programs at the Hoffman Heart and Vascular Institute at Saint Francis.

**IMPACT** Bob credits several physicians at Mount Sinai and Saint Francis for saving his life 30 years ago: Robert Cohen, M.D., Surendra Chawla, M.D. and Joseph Sappington, M.D. Bob recovered from his life-threatening injuries and has been coming to Saint Francis for his care ever since. He has developed a great admiration for his cardiologist, Dr. Sappington, and they have developed a mutually respectful relationship. For these reasons, the Goldberg’s annual IRA gifts were directed to support the construction and renovation of a catheterization lab so other cardiology patients can receive essential care in a high-tech and comforting environment.

## W.K. Kellogg Foundation

**GRANTS** – Throughout our history, grants have made an enormous impact on the programs and services we are able to offer our community. With the assistance of grants we have established the Child Advocacy Center, the Women’s Heart Program, the Lea Economos Hematology Center for Clinical Research, and the Curtis D. Robinson Center for Health Equity, just to name a few.

Saint Francis received a \$2.1 Million grant from the W.K. Kellogg Foundation (WKKF) to continue our partnership with the Hispanic Health Council’s “Breastfeeding: Heritage and Pride” (BHP) peer counseling program in the hospital’s Center for Women’s Health. The grant will be used to replicate and introduce the BHP program in three additional Trinity Health Of New England hospitals (Johnson Memorial Hospital, Mercy Medical Center, and Saint Mary’s Hospital). It will also be used to create a path for the replication of BHP at 37 other Trinity Health hospitals and to assist in Trinity Health’s goal of having 100% of its maternity hospitals reach Baby Friendly status over the next three years.

**IMPACT** A large body of evidence has shown that breast milk is the very best first food an infant can get and breastfeeding has significant health benefits for both mothers and their babies. These life-long health benefits include fewer cases of ear infections, gastrointestinal problems, Sudden Infant Death Syndrome, respiratory infections, eczema, asthma and weight issues. Babies who are breastfed have also shown higher cognitive abilities, fewer sick baby visits and hospitalizations and normal weight ranges. Saint Francis has met 80% of the Baby Friendly standards.

## 20th Paul Karvoski Annual Memorial Golf Tournament

When Paul Karvoski died of brain cancer in 1999, his parents, Jane and Steve, and brothers, Jim and Mark, chose to honor his memory and the care he received by hosting a golf tournament to benefit the Cancer Center. Golf was Paul's passion and his dream came true when he was able to play in the 1998 Greater Hartford Open Pro-Am Tournament. The family established the Paul Karvoski Memorial Golf Tournament, held at Blue Fox Run in Avon and hoped to raise \$100,000 for cancer research. This year they celebrated the 20th anniversary of their outing and surpassed over \$200,000 in proceeds.

**IMPACT** In 2010, the Karvoski family and the Cancer Center established the Karvoski Genetics Program. They hoped to give other families options for finding and preventing cancer and getting access to genetic counseling if they could not afford it. The program has grown from a part-time geneticist in one office to now include a medical director, two genetic counselors, administrative assistant, conference room and two locations within the Karl J. Krapek, Sr. Comprehensive Women's Health Center and the Smilow Cancer Hospital at Saint Francis. In addition, the program has hired a tele-genetics vendor which allows phone consultations during off-hours and on weekends.

### ESTATE PLANNING & GIVING

A revocable living trust is a useful estate planning tool that allows an individual to arrange how some or all of their assets will be managed after their passing. A last will and testament may help achieve a similar goal, but a living trust does not need to go through a complicated and potentially expensive probate procedure.
